#### **Board of Directors & Executive Committee**

- Updated CORE's Strategic Plan after identifying current strengths, weaknesses, opportunities, and threats.
- Supported a variety of innovative CORE projects designed to assist members and the communities we serve, including holding a Member Engagement Fair & Picnic free to all CORE members.
- Amended the CORE Bylaws to mandate mediation before arbitration.
- Voted in support of CORE members applying for leadership roles at New Jersey Realtors.
- Voted to recommend to New Jersey Realtors RPAC Trustees donations for several local political candidates.
- Worked to drive member engagement by sharing CORE Facebook posts and attending many CORE and NJ Realtors events virtual and in-person throughout the year.
- Communicated to the membership about plans for future CORE facilities consolidation.
- Worked throughout the year to ensure that CORE is well managed via oversight of finances, insurance coverage, regulatory filings, and obligations to NAR and NJ Realtors.

#### **Circle of Excellence Verification Task Force**

- Verified the award level of 596 New Jersey Realtors® Circle of Excellence applications.
- New record for the most applications received and the fastest time for the Task Force to complete the verification process.

## **Community Outreach Committee**

- Planned and held a fundraiser that collected \$1,460 and 68 lunches for Samaritan Homeless Interim Programs (SHIP).
- Held an online fundraiser for United Way of Hunterdon County's Tools 4 Schools program that raised \$560.
- Coordinated CORE's Realtors Care Day, which repaired the exterior of a home in need in downtown Trenton.
- Plan to hold a Thanksgiving food drive in November 2022 for veterans in need through Soldier On.
- Received approval for CORE to launch an annual CORE Good Neighbor Award program beginning in 2023.

#### **Diversity & Inclusion Committee**

- Following extensive research, the Committee successfully recommended two renowned national speakers for fair housing and understanding and appreciating cultural differences among real estate consumers.
- Applied for and was awarded the fair housing grant of \$5,000 from the National Association of Realtors®, which was applied to the CORE speakers' program.
- Hired Bill Dedman, NY Times bestselling author, Pulitzer Prize winner, and Peabody award-winning investigative journalist of Newsday's *Long Island Divided*, to speak about how his investigation raised awareness of illegal steering by Long Island's dominant brokerages.
- Successfully recommended that local real estate multicultural groups (Asian Real Estate Association of America, National Association of Real Estate Brokers, and National Association of Hispanic Real Estate Professionals) be invited to attend and participate in COREs first-ever Member Engagement Fair & Picnic.

#### **Finance Committee**

- Extensively reviewed CORE's reserve levels and investments and recommended changes to the BOD.
- Developed and recommended a 2023 annual budget for the BOD.
- Monitored CORE's 2022 financials to ensure adequate funding to meet the goals of CORE's Strategic Plan.

#### **Government Affairs Committee**

- Planned the Virtual Meet the Mayors Series for each county in CORE's association area: Hunterdon, Mercer, and Somerset.
- Worked to meet CORE's 2022 RPAC fundraising goal of \$81,575 with a 35.76% participation rate.
