- If granted membership in the Mid Jersey Association of REALTORS® (MJAR), I agree to complete the orientation process within 90 days of confirmation of membership. I otherwise agree on my own initiative, to thoroughly familiarize myself with the REALTOR® Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS® (NAR), including the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual of the Association and Constitution, Bylaws and Rules and Regulations of MJAR.
- I agree to abide by MJAR's Constitution, Bylaws, Rules and Regulations and the Code of Ethics of the National Association of REALTORS® and all actions taken pursuant thereto. I agree to pay the fees established as long as I am a member of MJAR.
- **I will complete the 2.5-hour REALTOR® Ethics Training and the 2-hour Fair Housing Training within 90 days of MJAR confirming my membership** via email and each three-year cycle, thereafter. The current cycle is Cycle 8 for years 2025-2027. I understand failure to meet this requirement may result in termination of my membership. (Once your payment is processed, you will receive instructions via email.)
- I understand that if applying for Primary membership, this application and fees submitted include membership in MJAR, New Jersey REALTORS® and NAR.
- I understand that dues and fees are non-refundable.
- I acknowledge that as a member of the Association I will be authorized to use the REALTOR® trademarks to indicate such membership, and I agree to abide by the rules governing use of those trademarks. I understand that REALTOR® is a federally registered trademark of the National Association of REALTORS® and use of this designation is subject to rules promulgated by NAR. Upon termination of my membership in the Association for any reason, my right to use the term REALTOR® is automatically revoked and I will immediately discontinue use of the term REALTOR® and all REALTOR® trademarks.
